Summary/Background:

The Roosevelt Ave ADA Ramp Upgrades Project will remove and replace deficient ADA ramps and install two marked crosswalks with rapid rectangular flashing beacon systems. Improvements will take place on Roosevelt Ave from Semanski St to Cole St in the City of Enumclaw, WA. City staff prepared engineering plans and specifications for the improvements and estimated the total project cost to be \$351,417.49. The 2026 budget has \$361,133.99 in Street/TBD/Grant funding for this project. A grant provided by the Washington State Transportation Improvement Board (TIB) will reimburse the City 80% of the total costs of the project.

On March 4th, 2026 12 bids were received for the project. The low bidder for this project was Diversified Holdings in the amount of \$199,297.00. The bid was determined to be complete and responsive. Diversified Holdings was determined to be qualified to complete the Roosevelt Ave ADA Ramp Upgrades project.

Staff recommends award of the Roosevelt Ave ADA Ramp Upgrades Project to Diversified Holdings in the amount of \$199,297.00 with a 15% contingency totaling \$229,191.67.

#### Background:

The Roosevelt Ave ADA Ramp Upgrades Project will remove and replace deficient ADA ramps and install two marked crosswalks with rapid rectangular flashing beacon systems. Improvements will take place on Roosevelt Ave from Semanski St to Cole St in the City of Enumclaw, WA. City staff prepared engineering plans and specifications for the improvements and estimated the total project cost to be \$351,417.49. The 2026 budget has \$361,133.99 in Street/TBD/Grant funding for this project. A grant provided by the Washington State Transportation Improvement Board (TIB) will reimburse the City 80% of the total costs of the project.

Notice of the bid opportunity was published to the Builders Exchange on-line bid service and the Seattle Daily Journal of Commerce newspaper on February 13, 2026.

#### Analysis:

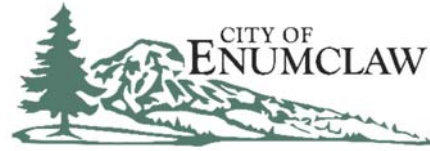
The bid submitted by Diversified Holdings was determined to be complete and responsive. Diversified Holdings was determined to be qualified to complete the Roosevelt Ave ADA Ramp Upgrades project. Construction management will be performed by city staff with an anticipated construction start date in June of 2026 with 45 working days allotted for construction.

It should be noted that the rapid rectangular flashing beacon systems will be installed by city forces and are not included as part of the contract with Diversified Holdings.

#### Recommendation:

Staff recommends award of the Roosevelt Ave ADA Ramp Upgrades contract to Diversified Holdings in the amount of \$199,297.00 with a 15% contingency totaling \$229,191.67.

Improvements will take place on Marshall Ave from Wells St to Railroad St in the City of Enumclaw, WA. Watermain replacements will take place at various locations throughout the City of Enumclaw and in King County. City staff prepared engineering plans and specifications for the improvements and estimated the total project cost to be \$973,550.52. The 2026 budget has \$420,000 in REET/TBD funding for this project for Schedules A and B. Schedules C, E, F, G, and H will be funded by the Water Utility. Schedule D will be funded by the Gas Utility.

Notice of the bid opportunity was published to the Builders Exchange on-line bid service and the Seattle Daily Journal of Commerce newspaper on February 6<sup>th</sup>, 2026.

#### Analysis:

On February 25<sup>th</sup>, 2026 10 bids were received for the project. The three lowest bid results are as follows:

As a result of the bids, an increase of transfer into the project fund from the Water Dept Fund by \$150,000 is required in order to complete the Water Main Replacement Program. The bulk of the additional cost can be attributed to additional water mains identified for replacement, permitting and inspection within King County. Several recent water system projects have come in under budget (Tacoma Intertie - \$250,000 instead of budgeted \$340,000; Boise Spring Main Replacement Phase 1 - \$750,000 instead of budgeted \$1,900,000). Therefore the Water Utility budget has sufficient funds available to cover the additional cost for this project. The final budget allocation for consideration with project award is the following:

#### **Background:**

On March 11, 2024, Council awarded a contract for the 244th Ave/Roosevelt Ave Intersection Improvement Project in the amount of \$1,261,140 to Sascon LLC. This project constructed the new roundabout, installed new sewer main, and upgraded gas main within the project vicinity. Funding was provided by a Washington State TIB grant, City Transportation Impact Funds, and Water/Gas department Funds.

#### **Analysis:**

Construction began on June 20<sup>th</sup>, 2024 and was originally scheduled for 70 working days. The project experienced delays due to unforeseen field conditions and contractor delays. Unforeseen field conditions consisted mainly of old concrete road panels beneath the roadway, unsuitable soils for compaction, and a mislocated water line. Contractor delays were mainly attributed to sewer main installation and a lack of contractor crew members onsite. Time and cost associated with these delays were tracked by City staff and additional compensation/time extension was provided to the contractor accordingly.

Substantial completion was achieved on January 7<sup>th</sup>, 2025, with 34.5 days of liquidated damages assessed at time of completion. Final cost at time of substantial completion were determined to be \$1,312,475.79.

On February 7, 2025, the City received a request from the contractor to renegotiate bid prices and to provide additional funds for project delays in the amount of \$342,878.56. City staff along with the City Attorney reviewed this request and determined that only a portion of this request was valid and agreed to an additional \$31,885.43 in compensation and a reduction in liquidated damages by 16 days.

Based on the City's revised final payment amount of \$50,870.32, this project is over the original contract amount by 6.6%. An additional \$21,395.66 in traffic impact funds will be required to cover the additional cost accrued.

Despite numerous discussions and exchange of correspondence, the City and Sascon have been unable to reach agreement on the final payment amount. Therefore, in order to close out the project and affirm the City's determination of the final payment due, Sascon has been informed that the contract will be presented to the City Council for unilateral acceptance.

#### **Recommendation:**

Staff recommends a budget amendment of \$21,395.66 and that Council unilaterally accept this contract as complete and to issue final payment to Sascon in the amount of \$50,870.32.

**Background:**

Many businesses within the city are affixed with burglar alarms. Alarm systems within the city, if the owner wishes for the Enumclaw Police department to respond, must obtain a registration for the site from the PD. When an alarm is activated, a notification is sent to the Enumclaw Police department for a response. Sometimes, these alarms have a fault or are triggered accidentally which can happen multiple times. “False alarm” includes the activities of a burglary and/or robbery alarm by other than an unlawful or attempted unlawful entry (to the premises) or when no robbery or burglary is being committed or attempted on the premises.

In the event the police department responds to a false alarm as a first occurrence, the person responsible (Owner/Manager) shall provide to the police department with the possible cause and correction to prevent future occurrences. If a second false alarm occurs within a six-month period, the person responsible shall submit a written report to the Chief of Police within three working (3) days. If a third false alarm occurs, the written report is required in addition to a statement from a certified alarm repair service with corrective action taken. If a fourth or more false alarms occur, the above is required and fees will be assessed for each response within a six-month period (see EMC 9.60.050).

The Police Department and Community Development Department have determined it’s an unreasonable amount of time to have the alarm repaired and to give notice and statement to the Chief of Police within three working (3) days. The Notice of Violation that would be issued by Code Enforcement gives 21 days to comply, which is ample time to make corrections and provide the Chief with a written report and a statement from the certified alarm repair service. The proposed amendment changes the notice requirement to the Police Department from 3 to 21 days, which is consistent with the current Code Enforcement procedures.

In summary, the proposed Ordinance No. 2836 amends the municipal code to allow 21 days to submit the notice as described above.

**Analysis:**

The amendment allows for more days to submit the required notice and statement to the Chief of Police.

**ORDINANCE NO. 2836**

**AN ORDINANCE OF THE CITY OF ENUMCLAW, KING COUNTY, WASHINGTON AMENDING ENUMCLAW MUNICIPAL CODE SECTION 9.60.050 REGARDING FALSE ALARM RESPONSE TIMELINES, PROVIDING FOR SEVERABILITY AND ESTABLISHING AN EFFECTIVE DATE.**

**Whereas**, the timeline for a property owner to provide a response to a false alarm is unreasonably short and is not consistent with the timelines for response for other code violations, and

**Whereas**, the amendment to the municipal code will provide consistency for property owners.

**Now, therefore, the City Council of the City of Enumclaw, King County, Washington do ordain as follows:**

**Section 1:** Section 9.60.050 of the Enumclaw Municipal Code is hereby amended as follows:

**9.60.050 Fees.**

A. The city shall impose the following administrative sanctions upon a police response to any false alarm:

1. Upon a first response to a premises at which no other false alarm has occurred, notice of the conditions and requirements of this chapter shall be given to the person having or maintaining such alarm system. The notice shall also request that possible causes of the apparent malfunction be examined, and any corrective action be taken to prevent future occurrences.
2. If a second response to a premises occurs as a result of a false alarm within a six-month period, the person having or maintaining such burglary

and/or robbery alarm shall, within ~~three~~ twenty-one (21) working days after notice to do so, submit a written report to the chief of police on a prescribed form setting forth the cause of such false alarm, the corrective action taken, and such other information as the chief of police or his designee may reasonably require to determine the cause of such false alarm, any mitigating circumstances and necessary corrective action. The chief of police or his designee shall be authorized to inspect or cause to be inspected the alarm system at such premises, prescribe necessary corrective action, and shall give notice to the person having or maintaining such alarm system of the conditions and requirements of this section. All costs of inspection and corrective action shall be borne by the individual having or maintaining the alarm on the premises.

3. If a third response to a premises occurs within a six-month period, the person having or maintaining such alarm system shall, within ~~three~~ twenty-one (21) working days after notice to do so, submit a written report to the chief of police on prescribed forms setting forth the cause of such false alarm, as well as a written statement by a certified alarm repair service, indicating the action taken and a statement of reliability. In addition, notice will be given that future occurrences within the same six-month period will result in a monetary assessment of \$50.00.

**Section 2: Severability.** If any section, sentence, clause or phrase of this ordinance and/or the attached exhibit should be held invalid or unconstitutional by a court of competent jurisdiction, such invalidity or unconstitutionality shall not affect the

validity or constitutionality of any other section, sentence, clause or phrase of this ordinance and/or the attached exhibit.

**Section 3:** Effective Date. This ordinance shall take effect and be in force five (5) days from and after its passage, approval and publication as required by law.

During the COVID-19 pandemic the city acquired a 40-foot by 80-foot tent for hosting outdoor events to provide prosperity for downtown Cole Street and to enhance public health, safety, and welfare. The City secured a ground lease at 1622 Cole Street in 2020 for the placement of the tent which continued through 2023. The 1622 Cole Street site was developed in 2024 with a new commercial building necessitating the relocation of the tent to 1404 Cole Street, a vacant lot. The city leased this location from the current owner for Apr-Dec 2025 at the prorated cost of the property taxes.

**Analysis:**

The current owners are willing to continue a ground lease for the event tent in 2026 with compensation to address property taxes. This ground lease would run from April 1-December 31, 2026 with a rent of \$368 per month for a total of \$3,312 for the term. An extension into 2027 is not included as the owners intend to proceed with developing this parcel.

## GROUND LEASE

THIS LEASE made this \_\_\_\_\_ day of March, 2026, by and between Enumclaw Cole Properties, LLC, hereinafter called the "Lessor", and the City of Enumclaw, hereinafter called the "Lessee".

**WHEREAS**, Lessor has a vacant lot that is appropriate in size and location to place Lessee's community event tent, and

**WHEREAS**, Lessor has no immediate plans for the vacant lot in 2026 and desires to lease the space to the Lessee to facilitate community events and functions;

**Now, therefore, the Parties agree as follows:**

### WITNESSETH:

1. **Premises:** Lessor does hereby lease to Lessee those certain lands legally described in Exhibit "A" attached hereto and incorporated herein as if set forth in full, commonly known as 1404 Cole Street, a vacant corner lot at Cole Street and Stevenson Avenue, Enumclaw, King County, Washington.
2. **Term:** The term of this lease shall commence the 1<sup>st</sup> day of April, 2026 and ending the 31<sup>st</sup> day of December, 2026.
3. **Rent:** Lessee covenants and agrees to a payment of rent of three-hundred sixty-eight dollars (\$368.00) per month. Lessee has the option of making a single rent payment for the entire term.
4. **Repairs and Maintenance:** Premises have been inspected and are accepted by Lessee in their present condition. Lessee shall, at its own expense, and at all times, keep the premises neat, clean and in a sanitary condition, and keep and use the premises in accordance with applicable laws, ordinances, rules, regulations and

requirements of governmental authorities. Lessee shall permit no waste, damage or injury to the premises.

5. **Utilities and Fees:** Lessee agrees to pay all monthly charges for any utilities required by Lessee, except that the stormwater utility charges shall be paid by Lessor.

6. **Accidents and Liabilities:** Lessor or its agents shall not be liable for any injury or damage to persons or property sustained by Lessee or others in and about the premises. Lessee agrees to defend and hold Lessor and its agents harmless from any claim, action and/or judgment for damages to property or injury to persons suffered or alleged to be suffered on the premises by any person, firm, or corporation, unless caused by Lessor's negligence.

Lessee agrees to maintain a minimum of \$4,000,000 per occurrence limit of liability coverage on the premises.

7. **Use:** Lessee shall use the premises for City events and events for non-profit agencies consistent with the promotion of community wellbeing and overall economic prosperity. The use includes the placement of a 40-foot by 80-foot tent, anchoring system, interior lighting and seasonal heating through a portable heating unit.

8. **Liens and Insolvency:** Lessee shall keep the premises free from any liens arising out of any work performed for, materials furnished to, or obligations incurred by Lessee and shall hold Lessor harmless against the same.

9. **Subletting or Assignment:** Lessee shall not sublet the whole or any part of the premises, nor assign this lease without the written consent of Lessor which will not be unreasonably denied.

10. **Access:** Lessor shall have the right to enter the premises at all times.

11. **Possession:** Lessor shall deliver possession of the premises to Lessee at the commencement of the term.

12. **Alterations:** Lessee may make alterations, additions and improvements in said premises, at its sole cost and expense, subject to Lessor's approval. In the performance of such work, Lessee agrees to comply with all laws, ordinances, rules and regulations of any property public authority, and to save Lessor harmless from damage, loss or expense. Upon termination of this lease and upon Lessor's request, or Lessor's approval, Lessee shall remove such improvements and restore the premises to its original condition at option of Lessor, not later than the termination date, at Lessee's sole cost and expense. Any improvements not so removed shall remain in and be surrendered with the premises as a part thereof.
13. **Taxes:** Lessor agrees to pay the real estate taxes and assessments applicable to the premises which are due and payable during the terms of this lease or any extension hereof.
14. **Default and Re-Entry:** If Lessee shall fail to keep and perform any of the covenants and agreements herein contained, including the payment of rent, and such failure continues for thirty (30) days after written notice from Lessor, unless the rent is paid or appropriate action has been taken by Lessee in good faith to cure such failure, Lessor may terminate this lease and re-enter the premises, or Lessor may, without terminating this lease, re-enter said premises, and sublet the whole or any part thereof for the account of the Lessee upon as favorable terms and conditions as the market will allow for the balance of the term of the lease and Lessee covenants and agrees to pay to the Lessor any deficiency arising from as re-letting of the premises at a lesser amount than herein agreed to. Lessee shall pay such deficiency each month as the amount thereof is ascertained by Lessor.
15. **Removal of Property:** In the event Lessor lawfully re-enters the premises as provided herein, Lessor shall have the right, but not the obligation, to remove all the personal

property located therein and to place such property in storage at the expense and risk of Lessee.

16. **Costs and Attorney Fees:** If by reason of any default on the part of the Lessee it becomes necessary for the Lessor to employ an attorney or in case Lessor shall bring suit to recover any rent due hereunder, or for breach of any provision of this lease or to recover possession of the leased premises, or if Lessee shall bring any action for any relief against Lessor, declaratory or otherwise, arising out of this lease and Lessor shall prevail in such action, then and in any of such events Lessee shall pay Lessor a reasonable attorney's fees and costs and expenses expended or incurred by the Lessor in connection with such default or action.
17. **No Waiver or Covenants:** Any waiver by either party of any breach hereof by the other shall not be considered a waiver of any future similar breach. This lease contains all the agreements between the parties; and there shall be no modification of the agreements contained herein except by written instrument.
18. **Surrender of Premises:** Lessee agrees, upon termination of this lease, to peacefully quit and surrender the premises without notice, leave the premises neat and clean, and to deliver all keys to the premises to Lessor.
19. **Holding Over:** If Lessee, with the implied or expressed consent of Lessor, shall hold over after the expiration of the term of this lease, Lessee shall remain bound by all the covenants and agreements herein, except that the tenancy shall be from month to month.
20. **Binding of Heirs, Successors and Assigns:** The covenants and agreements of this lease shall be binding upon the heirs, executors, administrators, successors and assigns of both parties hereto, except as hereinabove provided.
21. **Notice:** Any notice required to be given by either party to the other shall be deposited in the United States mail, postage paid, addressed to Lessor at 840 Hinckley Rd, #221,

Burlingame, CA 94010 or to Lessee at 1339 Griffin Avenue, Enumclaw, WA 98022 or at such other address as either party may designate in writing from time to time.

22. **Time is of the Essence of this Lease:**
