A. Secretary-Examiners Report

i. Civil Service Conference, October 21-22

McKee indicated that her biggest takeaway from Day 1 was in reference to Veteran’s preference points, and day 2 was enlightening to hear them discuss how to do away with Civil Service. Also had some good takeaways regarding creating a workplace that is attractive to outsiders, not just regarding Civil Service. “Let your people lead the way” because happy employees attract applicants, and people who want to stay.

B. Police Department Update

Chief provided a staffing update.

- Dispatch is fully staffed with two recent new hires who are currently in their probationary period.
- Corrections just lost one employee, but there is someone currently in background. If that does not pan out, we have exhausted the list and will need to run a recruitment.
- Patrol is fully staffed with one employee who has been in academy for two months now, and another just out of academy who will be on the streets under FTO soon. Officer Miller stepped down from his Detective assignment, so this will open up a vacancy there. This will be open for the unforeseeable future due to movement in many other areas.

- Sgt McCall will be retiring in summer of 2026, so a call for candidates will be going out in January with Sergeant promotional testing in mid-February. Then once that spot is filled, they will look for their next Investigations Sergeant and open a recruitment for patrol to fill the vacancy.

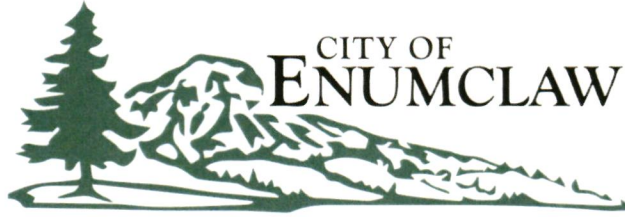


